With Prakas 648 of 2025, the General Department of Taxation has taken the Cambodian tax treatment of international shipping into new and unchartered waters. Employing a framework based on deemed profit ratios tied to revenue, the income tax impost in Cambodia for global shipping has been newly determined. While this formulary approach may be straightforward to apply in some cases, several important questions remain.
